# **Draft Congregational Meeting Minutes**

First Unitarian Church, South Bend **Annual Congregational Meeting** May 19, 2019

- 1. Call to order by President Chuck Leone at 12:00.
- 2. Quorum —The Secretary determined that a quorum of members (35 plus 7 proxies) was present.
- **3. Opening** Chuck Leone
- **4. Approval of Congregational Minutes** Florence Klecka <u>moved that the minutes of the May</u> **20**, **2018** Annual Meeting be approved as written. Roger Birdsell seconded. The motion was passed unanimously.

#### 5. Reports

- a) Minister reviewed
- b) President Chuck referenced his report on page 5 of the Annual Meeting booklet, emphasizing our successes at revising the children's religious education program, the hiring of Rich Wallace as the new Coordinator of Religious Education and the the ongoing work on the Strategic Plan. But he also highlighted some continuing challenges such as financial issues and the need for stronger marketing leadership.
- **6. Proposed 2019-2020 Operating Budget** (Report, pp. 6-8)
- Treasurer Elena Wake pointed out that the proposed budget has pledges of \$152,000 and Total Revenue of \$173,800.
- She also noted that on p. 7, line 205, our mortgage payments for the year are estimated at \$22,700. This includes payment on additional mortgage debt for roof repair and the fact that the mortgage interest rate will most likely rise when renegotiated in June or July.
- Another factor in the budget is that the Board raised the salary for the Coordinator of Religious Education, line 809.
- Barbara Williams asked how much the solar panels are saving us. Chuck said that this was difficult to say exactly because we also replaced the AC system, put in the solar panels and some of the electricity is being sold back to the utility. Elena found that our 2015-2016 cost was \$6,500 and now the cost is under \$2,000.
- A motion was made by Byrd Tetzlaff to adopt the 2019-2020 budget as proposed, seconded by Dan Groteke. Discussion centered around the proposed deficit of \$21,527. Joseph Gress pointed out that last year the budget deficit was \$5,000, and that year we had a surplus of \$11,000. Joseph raised a flag about a pattern of budget deficits as a long-term concern. Chuck said that typically we underspend our budgeted items and that leads to a surplus. This year our pledges have flattened, the CRE Director's salary has been raised and the north roof needs to be redone. We can cover the deficit with a combination of the 2018-2019 surplus, unrestricted savings and fund-raising for the roof which has already begun. The motion to adopt the budget passed unanimously with no abstentions.

#### 7). Endowment Disbursements

• <u>Joseph Gress made a motion to adopt the list of disbursements by the Endowment Committee, seconded by David Wistreich.</u> Ruth Regan asked where the playground will be. Rich Wallace answered that it will be in the fenced area on the north side of the RE wing. <u>The motion was carried unanimously with one abstention.</u>

#### 8). Elections

a) Officers and Trustees for 2019-2020 — Gary Metzler moved that the slate of Officers and Trustees as listed on page 11 of the Annual Report be elected. David Mayfield seconded.

The motion passed unanimously.

**b)** Endowment Committee Members — Lois Holm moved that the slate of two members for the Endowment Committee listed on page 11 be elected. Lynn McDonald seconded.

Three-year term Marilyn Shaul

One-year term Joseph Gress (filling remaining term of Suzanne Waller)

The motion passed unanimously.

c). Nominating Committee — <u>Dale Gibson moved that the slate from the Nominating Committee be elected</u>. Wendy Lohman seconded.

Chair Person: Chuck Leone (outgoing Board President, 1-year term)

New Member: Becky Lindstrom (two-year term)

Current Member: Wendy Lohman

The motion passed unanimously.

**Nominating Committee Alternate** — Lynn McDonald volunteered from the floor to fill the Alternate position. <u>Rich Wallace moved that Lynn McDonald be elected Alternate on the Nominating Committee</u>. <u>Jim Ward seconded</u>. <u>The motion passed unanimously</u>.

#### 9). Resolutions

#### **Resolution #1**

The Board of Trustees of the Church is hereby authorized to negotiate the renewal of the note and mortgage on the Church building at 801 E. Washington St., South Bend, Indiana, with 1st Source Bank, the current mortgage holder, at the prevailing interest rate for loans of this type, and under such other terms and conditions as the Board deems appropriate.

- Currently our mortgage consists of three five-year renewable notes. The first five-year note started in August of 2014 and will be ending in July of 2019.
- The old mortgage rate was 5.67% and Chuck estimates that it will rise to about 7.75%. The budget proposal for 2019-2020 includes the increased interest rate.
- Lois Holm wondered if the Board had shopped around for a better rate. Chuck said that we had not because of the good relationship we've had with 1st Source, but that we could if the membership felt it necessary.

- Susan Siemers said that our other accounts were there and we would have to change our other
  accounts if we switched.
- The question was raised if there would be closing costs and fees. Chuck said there wouldn't be because it was the same loan.
- Jim Curlee said that he felt we should stay with a business where we had a good relationship and service.
- Byrd Tetzlaff felt we should keep a business where we have a good relationship.
- Roger Birdsell made a motion to authorize the Board to negotiate the renewal of our mortgage note as written in Resolution #1. Dave Wistreich seconded. The motion passed unanimously.

#### **Resolution #2**

The Board of Trustees of the Church is hereby authorized a) to contract for the replacement of the north roof of the Church building along with associated work, for an amount not to exceed \$40,000; and b) to borrow the additional sum of not more than \$20,000 from 1st Source Bank to be added to the Church's mortgage loan with the Bank, to be paid under the same terms and conditions as the renegotiated mortgage loan with 1st Source Bank.

- We had an estimate a year ago from Dudek for \$36,600 that Dudek will hold for us. This includes removal and replacement of shingles, replacement of any damaged deck areas, removal of an old vent structure, installation of flashing and of ice and water shield underlayment. The north roof is larger than the south roof (which has already been reroofed) because the north roof includes the area over the sanctuary.
- There was a question about whether we had considered a metal roof. David Mayfield had suggested a metal roof earlier, but the Board had decided to stay with the shingles.
- Dan Holm asked about how this can be financed. Here are possible existing funds.

- Other possible sources of funds are: unrestricted savings, more Raise the Roof donations (only 8 people have contributed so far), and adding to our mortgage.
- Chuck said that we probably wouldn't need all of \$20,000. Discussion followed about whether to amend the resolution to lower the amount to \$10,000 or \$15,000. Larry <u>Dzuagis</u> said that it's better to have some extra because many projects run over.
- Joseph Gress asked if we have other major projects to undertake. Replacement of clerestory windows, \$1,000 in repairs to elevator and dishwasher were named.
- Barbara Williams asked if there would be a warranty on the work by Dudek. Kathy Vetter said we had worked with him before and had been very satisfied with his work and service.
- Ron Robinson pointed out that the more we can raise with the Raise the Roof campaign, the less we will have to borrow.

- How does a \$15,000 loan affect our mortgage payments? The budget proposal assumes a \$10,000 loan and a variation of about \$1,000 per year.
- A motion was made by David Mayfield and seconded by David Wistreich to adopt Resolution #2 as written. The motion was passed unanimously with one abstention and 2 proxy abstentions.

#### 10). Committee Reports

- **Stewardship** Gary Metzler said that the Committee had been working on a plan to enable the church to accept credit cards for pledges and for the auction. This will be coming soon.
- Several people felt that it should be easier to find the Amazon button on our website so we can get a donation to the church from Amazon when ordering.
- Melanie Smith-Guillaume noted how much work that all the committees have done over the year. The Annual Report lays out the volunteer time donated to the church. Thank you to all.
- **11). Peace and Justice Focuses for 2019** Reviewed.
- **12). Volunteer of the Year Award** Gail deSomer and Susan Van Fleit were honored as volunteers of the year.

- Jim Curlee wanted to show appreciation for the Nominating Committee. Thank you.

- **15. Adjournment** The meeting was adjourned at 1:15 pm.

# President's Report, Ron Robinson

This has been a tough few months for our congregation facing the challenges the coronavirus pandemic has presented. We have all had to get used to showing up on Sunday morning through Zoom. The Board has had to refigure how to conduct the business of the church collectively as one body and singularly as individuals from our home. Hand washing several times a day, wiping down door handles, keypads, cell phone screens and computers are now routines we all engage in without thinking twice. Face masks are a new fashion accessory to every outfit we wear. Even though we see each other virtually, every connection, every phone call takes on a heightened level of importance and we are so appreciative of the connection we have to one another. # Treasurer's Report, Elena Wake Finance Documents, Submitted by Finda Kamanda

We ended the last fiscal year (2018-2019) with a surplus of \$2,079 despite the projected \$11,671 deficit in the budget.

This year (2019-2020) the stewardship campaign received pledges of approximately \$152,000. The operating budget forecasted a deficit as well. However, thanks to cost saving efforts, we are expecting a surplus of approximately \$8,700 at the end of the year, if current trends as of the publishing of this report continue. We had successful fund-raising efforts. For example, the service auction brought in a record \$17,714 as opposed to the projection of \$11,000. We applied for Paycheck Protection Plan (PPP), a part of COVID-19 relief funds, and received a notice from the First Source Bank that \$16,000 was approved for the church. Although it is a loan, it is forgivable, if the fund is used appropriately as guideline (use it up within 8 weeks of receipt, at least 75% of it to be spent on payrolls and the remaining on utilities or mortgage).

The Stewardship drive for the next fiscal year (2020-2021) so far reported \$146,664 pledges, despite uncertainty of COVID-19 related social conditions. Notably this year, social distancing, closure of the building and unstable economy make it particularly difficult to forecast the budget. We focused on creating a balanced budget as much as possible, and in such efforts, unfortunately, we had to cut back on many funds.

We appreciate the generosity of our members and friends for financial and service contributions. Finance Committee Members: Janet Bogar, Karen Dickson, Fern Hamlin

#### **❖** Proposed 2020-2021 Operating Budget

At its April 29 meeting, the Board of Trustees agreed on the *Proposed 2020-2021 Operating Budget*, as shown in Table 1 below, for the Congregation's approval. The remaining principal owed on the building loan as of May 5, 2020 is \$143,879.

# Children's Religious Education Program Report - Rich Wallace

A year ago, I started as the CRE for our church with the goals of making our congregation more appealing to children and their families and to integrate them into the broader church community. To do this, we made sure there were programs and involvement opportunities for them on Sundays. We made sure there was childcare available for any church event or meeting, so that parents of young children could add their perspectives and talents to the work of the congregation. We also had events that were for all ages to promote interaction between our children and adults in a wholesome and fun manner.

With the help of the committee members, we planned Sunday lessons and established a consistent format to follow every Sunday for the children. This format started with being in the sanctuary until they were "sung out" after the Story for All Ages. When it was possible, we recruited children to read the stories. When the children were not available we had numerous adults volunteer to read the story giving, the kids more opportunity to become familiar with more adults.

Similarly to the congregation in the sanctuary, we incorporated some of the elements into each Sunday class. These included a chalice lighting, Joys & Concerns, Chalice extinguishing, and the closing covenant.

Different instructors were recruited to lead a class roughly once a month. We also had special celebrations of varying holidays and cultural events such as pagan holidays, Cinco de Mayo, International Ice Cream day, and the annual stocking stuffing for the CASIE Center.

The events that we had for all ages were a success. We had a Halloween party and an All Ages Dance party. Both were well-attended, and not only brought in members and friends, but people from outside the congregation. Participation in the downtown South Bend St. Patrick's Day Parade and a St. Patrick's party were planned but cancelled due to the pandemic. There was also another dance event being planned in coordination with the LGBTQ Center.

Aside from the childcare coordination, the Sunday activities, and the intergenerational events, we also hosted a monthly movie night that had varying degrees of attendance, but often gave parents an affordable entertainment option or a chance to leave their children in a safe place while they got a much needed Friday night respite.

As we move forward, figuring out ways to serve our young community members in the age of COVID-19, I look forward to continue to help the children feel welcomed in our congregation, parents feel supported, and our congregants feel secure that we're passing the torch to a new generation.

# **COVID-19 Task Force Report, Submitted by Chuck Leone**

On March 12, 2020, the Board of Trustees formed a COVID-19 Task Force to monitor and advise the Church on reopening the building for in-person services when the time is right. Mary Hagen and Chuck Leone volunteered to be on the task force and Howard Berberick is the Board liaison.

On May 1, 2020, Governor Holcomb's office issued new rules easing social distancing restrictions under certain conditions to allow services to be held. However, churches are still encouraged to hold services virtually especially for those who may be at risk of infection in the pandemic. Based on the data on the state's web site, however, St. Joseph County remains a location in which new cases continue to emerge daily and deaths continue to rise. Therefore, we recommend that services remain virtual at this time.

As we plan for reopening, we will be looking at the following areas of concern:

- Use of materials such as Orders of Service
- Serving of food and beverages
- Entering and leaving the building
- Arranging seating to maintain distancing
- Cleaning of the building between services
- Use of masks and other PPE
- Signage to remind everyone of protocols
- Air circulation in the building
- Visitor policies

#### Adult Religious Education Committee: Gail deSomer, Chair

"Building Your Own Theology," a series of 8 classes, was offered by Rev. Byrd Tetzlaff in the fall of 2019. BYOT allowed the participants to explore their own belief systems and how they came to them, and to learn how to articulate them. The course culminated in a worship service led by those taking the class.

"Explorations and Discoveries Class," led by Rev. Byrd Tetzlaff, was offered monthly in the winter of 2020. This class was a continuation of "Building Your Own Theology," with participants able to drop in for any of the classes.

Barbara Williams and Marilyn Shaul coordinated the "Great Decisions" course, developed by the Foreign Policy Association each year. The Foreign Policy Association was formed after WWI to educate the population about foreign affairs and to encourage support for the League of Nations. The Great Decisions program studies current issues facing our nation thru a short video and some reading materials by international experts providing information and opinions. The topics are followed by group discussion.

Rev. Chip organized and launched the small group "Mix Tape of Your Life," in which participants bring examples of music that have touched their lives, and discuss its importance to them.

Soliciting and thanking donations to the endowment fund

As of March 31<sup>st</sup>, we received 2 donations totaling \$ 350 in honor of Roger Birdsell, 6 donations totaling \$ 395 in honor of Dale Gibson and \$ 1,000 from the congregation as repayment of loan. We greatly appreciate these contributions.

- In 2019, our church awarded endowment grants for the following projects:
  - Archives
  - Memorial Garden
  - Mobile Ecology Center
  - o Natural Playground
  - North Roof Replacement
  - o Building Principal

We are excited about the progress that has been made on these projects during the last year.

• Soliciting and reviewing endowment proposals. We received 11 proposals totaling \$39,444 for endowment disbursements. Based on the congregationally authorized formula for disbursements, we are authorized to recommend disbursements for \$15,127.

#### **Endowment Committee Recommendations**

The Endowment Committee considered 11 proposals totaling \$39,444 for endowment disbursements. This was challenging because all of the proposals had merit but we were authorized to recommend disbursements for only \$14,732.

- 1) The Endowment Committee recommends that \$3,000 be approved for paying principal on the mortgage if necessary.
- 2) The Endowment Committee recommends "postponing any decision about other disbursements until" the Coronavirus crisis has been resolved.

#### **Summary of this Year's Endowment Proposals**

Here is a list of the proposals and amounts:

Religious education committee-OWL \$2,790

This is a plan to reinvigorate the curriculum on sexuality offered by the UUA called Our Whole Lives (OWL). The endowment grant would be used to buy two sets of books for each level of OWL for children (k-1, 4-6, 7-9, 10-12) because each course has at least two facilitators. We would also like to have more people trained as facilitators. Preferably a male and female facilitator for each level. The k-1 and 4-6 is one training while the 7-9 and 10-12 is another.

Finance committee- Mortgage \$5,000

Endowment grant to fund payment of mortgage principal for the fiscal year 2020-2021. The grant will be used toward the payment of mortgage principal, monthly starting July 2020 until exhausted in December 2020.

Care committee - Baby changing tables \$760

Two additional baby changing tables, one in the women's restroom and one in men's restroom. We also would install signage signaling where the baby changing stations are located.

Humanist Forum - Humanism in Star Trek \$600

Humanism in Star Trek", a program presented by Susan Sackett. Susan was executive assistant to the late Gene Roddenberry (creator of Star Trek) for 17 years until his death in 1991. She co-wrote several Star Trek: The Next Generation scripts and is the author of 10 non-fiction books about the entertainment industry.

Florence Klecka - Archiving \$3,500

I hope to complete the scanning (and sorting of yet more records received in the last two months) of Board minutes, minister information, newsletters (pre-Word documents), photos, and other information downstairs in the archives room, and write up protocols to keep them current.

Once the files have been mostly sorted, I would inform the various committee heads as to what is down there, and how to access it, either through the physical files or the computer.

Also, at least once a year, contributing to a service based on information found in the archives, and at least six times a year, updating a bulletin board with discoveries.

Ad-hoc Lighting committee \$5,824

The Ad-hoc lighting committee consisting of Ron Robinson, David Mayfield, Howard Berberick, Kathy Vetter and Jim Ward was appointed by the board to make recommendations about outside lighting improvements. The committee recommended the following set of improvements to upgrade the outside lighting of the First Unitarian Church of South Bend to create a safe, well-lit and inviting presence of the church building at 801 E. Washington. These upgrades will make access and egress safer for those attending functions so they can clearly see where to walk. It will also deter vandals from breaking into or destroying church property even when persons are not present at the facility. It will also create a warm and well-lit building that identifies to the community what this building is at night for those who pass by.

Ad-hoc group - Janitor \$8,000

This proposal from Lois Holm, Dan Holm, Jim Curlee, Becky Lindstrom, Kathy Platt, and Tom Platt is for a quarter-time/on-call janitor for our building at 801 East Washington.

The janitor's responsibilities might include monitoring HVAC systems, scheduling regular inspections and maintenance of equipment and making miscellaneous minor repairs.

Building committee- Indoor Lighting Improvements \$990

We would like to make lighting changes in two areas of the building that were not upgraded during the building renovations. These are:

- West Stairway: Landing Light Fixture and Light Fixture at bottom of west stairway
- Clerestory Lights

Building committee - HVAC adjustments \$7,350

Since the installation of our HVAC system in the spring of 2016, over time we have observed some ongoing issues including uneven distribution of heat within zones and inability to heat all peripheral zones on cold days. This proposal addresses these issues.

#### *Grounds committee - North Patio \$4,200*

The Grounds Committee is now focusing on a renovation of the north yard. Our plan is to remove the two concrete pads that are there and install a stamped concrete patio approximately 400 square feet with a 20' x 4' sidewalk leading north from the patio to the existing sidewalk.

#### Diana Mendelsohn-Ecology education events \$430

We are proposing to co-host with the Holiday Bazaar Committee a green gift making event next December. This June, July, and August, plans will be to solar cook muffins or gluten-free tacos to be eaten after our service on a sunny day with our Solar Oven. I met with the Landscape committee as scheduled during their February 16 and proposed growing tomato plants in various sunny locations, to be dedicated to the children. Finally, the Summer Solstice Celebration is scheduled to take place on Saturday, June 20, from 12-5 pm CST, Roseland Park, will feature solar cooking demonstrations, planting of kids pizza gardens, music, community safety exhibits, live drum circle, wildflower yoga demonstration, live animal petting zoo, artists selling items, bike ride on the LaSalle trail, wildflower hike.
