- I. Call to Order at 12:13 by Anne Mannix
- II. Quorum Verification attested to by secretary Kay Azar. There are 42 members present and signed in.
- III. Opening Words by Rev. Chip Roush
- IV. Approval of 2021 Annual Meeting Minutes Anne Mannix A motion is made by Jim Gibson, seconded by Barbara Boyd. Motion carried.

- VII. Operating Budget: Anne Mannix and Catherine Lundergan Our finances look good for the year and it looks like we'll be breaking even for the year. Next year's budget is a deficit due to pledges being down and expenses increased as we come back to in-person meeting. We traditionally project a deficit budget every year, it is pointed out, so there is no reason for panic. Susan Siemers moves to accept the budget. Motion seconded by Byrd Tetlaff.

Barbara Williams moves to table the budget, seconded by Mary Alice Lundergan.

Concerns are expressed because the budget was released just last night electronically and printed today, many need more time to look into the budget more fully before being required to vote on it. What are the mechanisms to make this happen? We would need another congregational meeting within the month, but no date set, could be at the June 5th meeting or after a service.

Another concern is that Catherine is resigning and that there is not a treasurer on the proposed slate of officers.

Motion to table the budget fails with 8 for, 30 against, and 4 abstentions. The budget will be voted on at this time.

It is pointed out that there are mechanisms for controlling the budget during the year. The original motion to pass the budget passes with 4 abstentions, 5 against. Motion carried.

Minister's Report, Rev. Chip Roush

Given the success of our Religious Education program's *Dungeons and Dragons* games, and the interest of some adults in *D&D*, *Pathfinder*, and other role playing games (RPGs), please allow me to use such games as a framing device for this report on our 2022-'23 congregational year.

In most RPGs, a group of folks congregate to tell a story together. In the game, their characters face challenges and collaborate to find creative solutions. At certain agreed-upon intervals, the storytellers pause to explicate how the characters have changed and grown. At most such intervals, there are still issues facing the characters.

This year we had marvelous adventures, and we still face some challenges. While these are chronicled in more detail, elsewhere in this grimoire, here are some highlights. We are emerging from the worst of the pandemic with many people working very hard. We've started an Adult Forum, held two Town Hall meetings, and celebrated our 70th Anniversary with a whole weekend of activities. We worked with *Faith In St. Joseph County*, going to Indianapolis to help secure funds in the state budget for crisis response care. Before this campaign is over, we'll welcome back our friends *Frances Luke Accord* in concert.

We grew as much as we have in at least five years, welcoming toddlers, retirees, and many ages in between. Our congregation's staff grew, too, at least in depth, as Pat Davis took over as sole Office Manager and Ian Bunker grew from accompanist to *de facto* Music Director. If this really were a game, both Ian and Pat would "level up" for their excellent work in their roles.

In RPGs, players may take a while to learn how to use their magic successfully. This is one of our challenges, as we continue to learn how to best use the specific magic of the internet and Zoom. Our services are multiplatform, and we're still experimenting with how to make the online experience more robust and more

welcoming. Our Board and some committees allow participation via Zoom; others find it unsatisfying. We are exploring how Coffee Hour might include at least some Zoom chatting.

The most powerful magic, of course, is the human heart's drive toward connection and compassionate action. We will continue to explore that magic in our next campaign!

Treasurer's Report and Finance Documents

Treasurer's Report, Elena Wake

The FY 2022-23 budget started with an expected deficit of \$28,082. On the income side, as of April 30, 2023, we collected \$116,203 of pledged \$130,000. Annual auction brought \$13,963, a lot more than \$11,000 in the budget. Loose offerings is exceeding the budgeted amount as well. On the spending side, the fire sprinkler system had a 5-year inspection which wasn't budgeted for, and one sprinkler head needed to be replaced in addition to other unexpected building-related repairs. We didn't use \$10,000 allocated for CRE (DRE). Office admin payroll had some excess due to transition from the previous assistant to the new. The board approved use of Capital Campaign fund (\$4,888 as of 1/31/2023) and Building fund (\$445 combined total 1/31/2023 through 4/30/2023) toward payment of mortgage principal.

All these combined, the best estimate of this fiscal year ending is a deficit of \$13,712. Although it appears that we did fairly well at a glance, an analysis would tell us different. As explained earlier, the largest savings came from the unused CRE salary, the use of Capital Campaign and the Building Fund to assist the mortgage payment. These should reduce the deficit to \$12,749 (=28,082 -10,000 -4,888 -445) but we are expecting a larger deficit. At best, we end at exactly where we should be if we spend less in the remaining months. The resulting deficit will be covered by the Unrestricted Savings (\$37,923 as of 4/30/2023).

Looking into FY 2023-24, the proposed budget by the board is anticipating a \$26,443 deficit. The budget includes a 2% rate increase for the office assistant and the bookkeeper, a cost increase of approximately \$200 for the year. The board approved the raises to keep up with increasing rates in the labor market. Note that due to an extremely large expected deficit, for the first time the CRE salary was excluded from the budget. We will start the year with an Unrestricted Savings of \$24,211 (=37,923 -13,712) after offsetting the FY 2022-2023 deficit.

At the end of FY 2023-24, it is very possible that we see the deficit very close as predicted. In some years we fiscally performed well because the CRE salary was often underspent and it worked as the largest fiscal cushion to reduce deficits. We no longer have that safety net. In addition, there may not be enough Unrestricted Savings to offset the entire FY 2023-24 deficit. This means that we must balance the budget for years after FY 2023-24.

We have \$106,556 of mortgage principle as of April 30, 2023. The mortgage was renewed in September 2019 for a term of 5 years with an interest rate of 6.25%. At this rate, we have 7 more years to pay off the loan. The next mortgage renewal will be coming up in September 2024.

Notes:

- 1) Three principal payments totaling \$3,171.68 are shown on the Mortgage Line (205) for FY 2022-23 YTD. All other principal payments were made from Non-Operating Funds. See Tables 2 and 3 for details.
- 2) Although nothing was budgeted for the Building line (240) in the FY 2022-23 budget, we have had, and will have more, miscellaneous building repair expenditures this year.
- 3) Starting in July 2023 we will record internet expenditures on line 330 (*Telephone*) instead of line 410 (*Admin & Office*). Therefore, we have changed line 330's name to *Telephone & Internet*.
- 4) The FY 2022-23 YTD balance for Elevator & Sprinkler (line 370) exceeds the 2022-23 budget due to expenses related to previously unknown, but required, 5-year fire sprinkler system pipe inspections (\$1100) and the replacement of one sprinkler head (\$850).
- 5) For FY 2023-24, a new expense line was added for the Board of Trustees (line 705).
- 6) For FY 2023-24, the names of expense lines 808 and 809 have been changed from *DRE* to *CRE* Professional Expenses and *CRE* Salary, respectively (Director vs. Coordinator).
- 7) For the FY 2023-24, we did not budget anything for expense line 809 CRE Salary.
- 8) The Board approved a 2% increase for the office assistant and bookkeeper for FY 2023-24.
- 9) This year's Miscellaneous Expenses (line 999) included \$150 for the Acting Ensemble. Members donated this amount, which was recorded on Income line 199 (Misc./Other Revenue). The additional \$61 in Misc. expenditures was for the Board of Trustee's expenses.
- 10) The true FY 2021-22 surplus was \$2,253. However, due to a \$16.77 credit on our AEP account at the end of the FY, only \$2,237.08 was transferred to Unrestricted Savings.
- 11) The current deficit includes the \$1,350 transfer from the General Fund to Special Collections for the Service Auction's designated "YWCA Donation" item (see Table 2 below).

- 2) For details of the Endowment Disbursements, see Table 5 below. The additional \$5 in the balance here compared to the total in Table 5 is due to a \$5 residual balance in a 2017-18 grant completed in its first year and not shown in Table 5.
- 3) The Board approved a \$1,000 donation to *Faith in Indiana* from the Invisible Church fund. A special collection raised \$935.81, which was transferred to the Invisible Church fund.
- 4) We transferred the \$15,200 in FY 2022-23 prepaid pledges to the General Fund on 7-1-2022.
- 5) The current total for the Special Collections fund includes: \$50 for CASIE Stockings, \$50 for Rebuilding Together, and \$17,030.31 for Ambroise Niyongabo/the Niyongabo family.
- 6) This year's Service Auction raised \$1,350 for the YWCA. Before making the donation, we transferred this amount to Special Collections from the General Fund.
- 7) For details of the Special Project funds, see Table 6 below.
- 8) On June 30, 2022, we transferred the FY 2021-22 Operating Budget surplus of \$2,237.08 (see Table 1) from the General Fund to Unrestricted Savings. This transfer is reflected in the 6/30/2022 Unrestricted Savings balance.

The Building Committee met on April 30, 2023, with David Mayfield, Kathy Vetter, Howard Berberick, Gail deSomer, Kathy Platt, and Pat Littlejohn in attendance.

We talked briefly about the important work that these individuals have been and continue to do for the maintenance of our church building.

We discussed the work needed on ceiling tiles in the narthex and meeting rooms, and David will check on rosettes to secure the tiles to the ceiling. The plan is for David and Pat to rent scaffolding to re-glue missing tiles and screw rosettes to all of the tiles in the narthex. It is not clear how long this might take, so we will have to look at the church schedule to see what dates give us the most flexibility and when we both can do it.

We discussed the budget process and the somewhat reduced building line, which will help get the figures closer to balancing.

We discussed the endowment fund request and our expectation that we will receive partial funding, which should enable us to work on getting some camera/intercom capabilities, and some re-working on some other exterior lights to help illuminate areas that need improvement, especially when there are events at the church. Pat will check on Ring and Wyze doorbell options. The first idea of a screw-in lightbulb that provides these capabilities has not proven out to be workable. We did a quick tour to look at the can lights around the building and discussed options for elevating the light production from them.

Children & Youth Religious Education (RE) Program Report Current Co-Directors of the DREAM Team: Becky Lindstrom and Gail deSomer

During the summer we offered play-based activities outdoors. As the weather became colder, we moved activities indoors. Beginning in September we focused on a new UU principle each month. We would explore the theme through games, role-play, art activities, and Dungeons and Dragons. We used a one-room schoolhouse approach and had between 2 and 10 children in attendance. Diana Mendelsohn provided childcare for those four and younger. Occasionally the younger children would join the older ones depending on the activity.

In addition to Sunday morning activities we had a Halloween party at Potowatami Park, provided Christmas stockings for the C.A.S.I.E Center, had a "Green" Holiday party organized by Diana Mendelsohn, enjoyed a Games Night in late January, celebrated an Easter Egg Hunt in April, and are planning a playground meet-up in May.

Some progress has been made in our outdoor play area – tree stumps for an outdoor classroom and climbing have been installed. Future plans include a balance beam sectioning off a garden area and a rain barrel under the slide for crawling through.

Tama Crisovan and Rich Wallace will receive O.W.L. training in May. Our goal is to then offer a middle or high school O.W.L course in the fall of 2023.

There is now a Facebook Messenger group for the parents and grandparents of children participating in Religious Education. This group serves to announce activities in addition to the *Chirp*. The group also allows parents to communicate with each other and build community.

We used a team approach to planning and executing activities, calling ourselves the D.R.E.A.M Team to signify Directors of Religious Education and Mindfulness. Many thanks to Becky Lindstrom, who had the vision to implement this team approach and worked to reestablish our Religious Education program for children. Becky will be leaving our team this year, and we welcome Kaely Barwick to the team.

The team included: Rev. Chip, Gail deSomer, Becky Lindstrom, Lauren Keck, Diana Mendelsohn, Megan Sulok, and Kaely Barwick. Many thanks also to Brett, Forest, and Sorin Keck for helping each month with Dungeons and Dragons.

Thanks also to Mary Hagen, Byrd Teztlaff, Mary Beth Dickey, and MaryAnn McDowell for help with activities this past year.

Endowment Committee Annual Report and Recommendations Chuck Leone, Chair

The Endowment Committee of the First Unitarian Church has received five requests for funding from the Endowment Fund for the 2023-2024 Church Year as follows:

- A. A request from the Social Committee, RE Committee, Grounds Committee and Building Committee to install an exterior door and sidelight from the RE classroom closest to the sanctuary to the outside enclosed patio area, including updated security, in the amount of \$12,550.00.
- B. A request from the Building Committee for exterior lighting, cameras and a doorbell/intercom for the back door of the Church in the amount of \$4,890.00.
- C. A request from the Finance Committee for paydown of the principal balance on the church mortgage in the amount of \$7,000.00.
- D. A request from Barbara Williams on behalf of the Adult Education Forum for wall-mounted display cabinets and boards and meeting communication enhancements to allow better remote participation in programs in the amount of \$10,000.00.
- E. A request by Anne Mannix on behalf of the Adult Education Forum for a "Meeting OWL" communication device in the amount of \$1,049.00 with a net cost of \$190.00 with re-allocation of certain unused funds and the donation of a laptop to run software.

Based on the criteria for Endowment Fund disbursements and the formula for funding of grants, all proposals submitted for funding this year are eligible. However, the total amount requested is \$34,630.00. The maximum amount to be funded this year is \$16,069.00 based on 5% of the average Fund balance at the end of the 4 prior calendar quarters. Requests exceed the maximum amount by \$18,561.00.

The Endowment Committee therefore recommends the following expenditures from the Endowment Fund and the re-programming of certain unused funds from the current year's Endowment grants as follows:

1. Approval of the request for the construction of the exterior door and sidelight including security updates in the amount of \$12,550.00

- 2. Approval of the request of the Building Committee for lighting, cameras and an intercom for the back door to the Church in the amount of \$2,500.00 with a recommendation of priority for the back door doorbell/intercom system.
- 3. Approval of the request for paydown of the Church's mortgage principal balance in the amount of \$7,000.00.
- 4. Approval of that portion of the Adult Education Forum request for the Meeting Owl, under the terms and conditions of the separate request by Anne Mannix, as described in the following item.
- 5. Approval of the request for a "Meeting OWL" communication device for the Adult Forum subject to reprogramming of unused funds from a previous technology grant in the amount of \$859.00, leaving a net cost of \$190.00, and contingent on the donation of a laptop computer by Anne Mannix to run the OWL software during meetings.

The total recommended for funding of these proposals is \$22,240.00 which exceeds the amount calculated as available by \$5,631.00. However, there remains \$3,000.00 unspent from the 2022-23 Endowment Grant for the Church's 70th Anniversary Celebration. The Endowment Committee recommends that the amount be re-allocated to this year's funding cycle, leaving an overage of \$2,631.00 in expenditures beyond the calculated funds available.

The Committee recommends the funding presented in this Report under the terms and conditions described above.

- Surveyed the congregation for their ideas/feedback on marketing efforts

 - o Major takeaways from the survey include
 - We need to <u>increase our visibility</u> in a variety of ways including
 - Collaborating with groups in the local community
 - Online using social media
 - Highlighting our values and identity in all of our spaces
 - We need to <u>identify and center our target audience</u> in our church activities
 - There is a vague sense that we need to bring in families, but a real lack of clarity on specifically who we want.
 - Many of our events seem out of touch with the target audience, so we need to re-center that group's needs in all that we do.
 - Email Marketing is our strongest form of marketing.
 - We have some deeper issues that are going to continue to undermine our marketing efforts. This includes intergenerational issues, being authentically welcoming, and a

need for increased positivity. These need to be addressed at the congregation level.
