## Church Mutual/Property/Liability Insurance

In an attempt to be helpful, I'd appreciate getting an email (RNugent@uua.org) with the details of your experience, e.g., Congregation Name, Address, Contact Info, Company Involved, Cancellation or Skyrocketing Premiums, Reason for cancellation, how much was your coverage and premium for your most recent year, etc.....I'll assemble the data, and bring it to the attention of our insurance broker who will likely have alternatives available. Normally, responsibility for this lands on the UUA Treasurer/Chief Financial Officer, but we are in-between people." – from Richard Nugent.

## ACTIVITIES

From Monday, September 25, through Sunday, October 29, 2023, there were five weeks; my contract calls for an average of at least twelve units per week, for a total of 60+ units (where a unit is defined as a morning, an afternoon, or an evening of work, in general).
