Report to the Board of the First Unitarian Church of South Bend, Indiana Rev. Chip Roush 13 December 2023

INFORMATION

Dr. Shuman has asked for a waiver, to rent the building for the memorial service honoring the life of his wife, Marcia, for a cost of \$1,000. He'd like the service to be Friday, April 12, at 2:00pm.

Pat Davis has requested that her pay rate be adjusted to the new rate of \$19/hour as of 1/1/24, whether or not she is training a new Office Manager at that point. Her last day will be January 21, 2024, unless she is training the new person (or has received that increase in pay rate).

With COVID-19 hospitalization rates again rising, we probably should revisit our policy. Please see the appendix for some background and my thoughts.

Our UUA's Annual Program Fund will ask us for \$9436 for FY25 (up from our Fair Share amount of \$8895 for FY24)

General Assembly will be online-only next year: June 20-23, 2024. It will be multiplatform again in 2025, with the in-person aspect held in Baltimore, Maryland (June 19-22, 2025).

Our MidAmerica Regional Assembly will take place April 19-21, 2024. At least some of the events (including a semi-famous Keynote Speaker?) will also include our friends from the Pacific West Region. As such, virtually all of the Assembly will be accessible online *and* there will be at least one in-person gathering in each Region. The in-person gathering for MAR is tentatively planned to occur in Madison, Wisconsin.

I will take six days of vacation, from Tuesday through Sunday, December 26-31. Monday January 1, 2024 is the New Year's holiday; I'll be in the office on Tuesday 1/2/24, and plan to preach on Sunday, 1/7/24.

ACTIVITIES

From Monday, October 30, through Sunday, November 26, 2023, there were four weeks; my contract calls for an average of at least twelve units per week, for a total of 48+ units (where a unit is defined as a morning, an afternoon, or an evening of work, in general).

Subtracting 2 units for the holiday, 6 units of vacation, and 4 units for study leave, that leaves a contractual minimum of 36+ units of work. Over that November time period, I recorded 37 units. Join a local Board, and share my engagement with the congregation I now serve on the URC Board.

Learn and practice emotional regulation exercises, such as Positive Intelligence, etc., and report on progress therewith in the Monthly Minister's Report.

I've read two chapters of the *Positive Intelligence* book I've tentatively joined a small group to explore this book with a trained leader

Maintain 3/10 boundaries (no more than three evening events per week, and no more than ten evening events pers month, except in emergency)

From Monday 10/30 through Sunday 11/26, I attended 1-3-2-1 evening events, successfully observing this boundary.

Offer at least one Adult RE course, of at least three sessions

The Adult RE Committee and I will discuss this sometime soon.

Remain and chat through an entire Coffee Hour (or until 1:00pm, whichever comes first), monthly (possibly to include engaging people still at Coffee Hour after I leave a meeting) I was at church through Coffee Hour / potluck, after 1:00pm, on 10/8, 10/22, 11/5, and 12/3.

Visit and/or contact one or more "homebound" member per month.

I have reached out to one "homebound" member so far in December.

APPENDIX - COVID-19 POLICY IN 2023-'24?

We have not had an in-person Christmas Eve service since the pandemic began.

Seven UU congregations collaborated to create Christmas Eve 2020, with several taped sections (including a simulated, but still surprisingly moving, Candlelight ritual) and a few sections live from various church buildings (as I did the chalice lighting from our sanctuary).

In 2021, after vaccines and summer gave us a reprieve, the virus returned with the autumn, and got even worse in December. Disheartened, we moved the service online; I led a sparsely-attended service from my home.

Last year, we had a robust service planned, but again the virus resurged. Just two days prior to our Christmas Eve service, the CDC reported St. Joseph County at "orange" levels. Ian Bunker, Byrd Tetzlaff and I presented the service while socially distanced in the Sanctuary.

How shall we plan for this Christmas Eve, and through this winter?

The CDC guidelines have been relaxed, now that many have been vaccinated and/or had at least one bout of the COVID-19 virus. They no longer recommend masking indoors for people who are not immunocompromised, or who live with or interact regularly with folks who are immunocompromised.

I would prefer that we all mask, so that everyone would feel safe and welcome in attending. That is not a realistic goal, I fear. I will likely wear a mask, when I'm not preaching. Others will, as well, and many will not. Many feel comfortable eating and drinking in a crowd, even as the hospitalization rates begin to climb again.

I do not envy you your task, and I welcome any conversation, privately or publicly, about a path forward. Clarity is necessary, in our policy and our source(s) of data. Not just for Christmas Eve, but for the planned pancake breakfast on 12/31, and for all of our activities through the winter.
